I AGREE NEITHER THE LONGVIEW CHARITY HORSE SHOW ITS PRINCIPAL AND AGENTS, THE LONGVIEW HORSE PARK GROUNDS, THE STATE OF MISSOURI OR THE MANAGEMENT OR THE OFFICIALS OF THE SHOW WILL BE RESPONSIBLE FOR ANY ACCIDENT, DAMAGE, LOSS OR INJURY TO MOUNT, OWNER OR OTHER PERSONS OR PROPERTY. IT WILL BE THE CONDITION OF ENTRY THAT EACH EXHIBITOR SHALL HOLD THE HORSE SHOW AND ITS MANAGEMENT BLAMELESS FOR ANY LOSS OR ACCIDENT TO ANY ANIMAL, PERSON OR PROPERTY THAT MAY OCCUR FROM SICKNESS, FIRE AND OTHERWISE AT THIS SHOW.

Equestrian Entry Agreement: By entering Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider or Handler, Vaulteer or Longeur and on behalf of myself or my principles, representatives, employees and agents and I agree that I am subject to the local rules of the competition. I agree to be bound by the Constitution and Rules of the competition. I also accept as final the decision of the hearing committee on any questions arising under the rules, and agree to release and hold harmless, the competition, the Federation, their officials, directors and employees for any action taken against the Rules I represent that I am eligible to enter and/or compete under the Rules, and every horse I am entering is eligible as entered. I also agree that as a of and in consideration of acceptance of entry, the competition may use or assign photographs, videos, audios, cablecasts or other likeness of me and my horse taken during the course of the competition for promotion, coverage or benefit of the competition or sport. These likenesses will not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity or to misappropriation. Longview Charity/Saddle Up Inc. Equestrian Release, Assumption of Risk, Waiver and Indemnification This document waives important legal rights. Read it carefully before Signing I AGREE in consideration for my participation in this Competition: Longview Charity Horse Show I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, vaulteer, longeur, lessee, Owner, agent, coach, trainer, or as a parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death ("Harm") I AGREE to release the Competition from all claims for money damages or otherwise for any Harm to me or my horse for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the Federation or the Competition. I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Competition. I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Competition and to hold them harmless with respect to claims made by others for any Harm caused by or my horse at the Competition. I have read the Competition Rules about protective equipment, and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the Federation strongly encourages me to do so while warning that no protective equipment can guard against all injuries. If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of this Release on the child's behalf. I AGREE that "Competition" as used above includes all of their officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations. I represent that I have the required training, coaching and ability, to safely compete in this competition. Every horse owner, banner, rider, driver or handler and any of their employees, agents, assistants or assigns who participate in or attends the Longview Charity Horse Show expressly assumes the risk of all injuries, loss or damage whatsoever to persons or property of whatsoever kind or nature as a result of the actions, whether caused directly or indirectly, and whether or not injury or damages resulted from the intentional reckless, negligence or other act or omissions of SADDLE UP INC, MHSA, PEHSC, LONGVIEW HORSE PARK ASSOCIATION, AND OR JACKSON COUNTY, MISSOURI, or their officials, directors, employees, agents, assigns and the Owner or Trainer identified above shall indemnify SADDLE UP INC., MHSA, PEHSC, LONGVIEW HORSE PARK ASSOCIATION, AND JACKSON COUNTY, MISSOURI and their officials, directors, employees, agents or assigns against and all claims. Actions or causes of actions of any kind that may be brought against them or any of them arising out of participation of any horse, rider, driver or handler entered by the above Owner or Trainer or by any of their attendance at the Longview Charity Horse Show, including a reasonable attorney fee. Further, each horse owner, trainer, rider, driver and handler who participates in the Longview Charity Horse Show expressly assumes the risk of sickness, communicable disease, fire or other acts of God or nature associated with livestock competition and the Owner or Trainer identified above shall completely indemnify and hold harmless SADDLE UP INC., MHSA, PEHSC, LONGVIEW HORSE PARK ASSOCIATION. AND/OR JACKSON COUNTY, MISSOURI and their officials, directors. Employees, agents and assigns therefor, including a reasonable attorney's fee, for any persons or livestock entered in the Longview Charity Horse Show by said Owner or Trainer. Every entry shall constitute an express agreement and affirmation that the person making it, along with the owner, lessee, trainer, agent, coach, driver, rider and the horse; (1) shall be subject to the rules and regulations of the Missouri Horse Show Association, Inc. PEHSC and the rules of the Longview Charity Horse Show; (2) that every horse, rider, handler and/ or driver is eligible as entered; (3) that the Owner or Trainer has the authority to consent and does in fact consent to the entry of any minor and said Owner or Trainer enters in the Longview Charity Horse show and accepts complete responsibility therefor. (4) that the owner or trainer and any of his or her representatives are bound by the rules of MHSA, PEHSC and the show and will accept as final the decisions of the Hearing Committee on any question arising under said rides and agree to hold the Show, the MHSA, the PEHSC their officials, directors and the employees harmless for any action taken.; (5) that the laws of the State of Missouri shall govern all actions arising out of the operation of or participation in the Longview Charity Horse Show except as expressly stated here **BY SIGNING ON THE FRONT OF THIS DOCUMENT, I AGREE TO BE BOUND BY ALL APPLICABLE COMPETITION RULES AND ALL TERMS AND PROVISIONS OF THIS ENTRY BLANK.**
